Supervision & Staffing

- Use must be directly supervised at all times by a trained and competent adult aged 21 or older.
- Supervisors are responsible for:
 - Enforcing all safety rules
 - Monitoring weather, surface, and wind conditions
 - Conducting pre-use inspections

Participant Eligibility & Consent

- Written parental/guardian consent is required for all minor participants.
- Any participants must not participate if they:
 - Have heart disease, high blood pressure, epilepsy, neck or spinal injuries, or other medical conditions that make participation unsafe
 - Are recovering from surgery or injury, feeling unwell, or physically weak
 - Are pregnant
 - Have impaired vision that could affect safe use
 - Are under the influence of alcohol, drugs, or other psychotropic substances
 - Display aggressive, unsafe, or rowdy behaviour
- Final approval for participation is at the discretion of the supervising adult.

Weight & Capacity Limits

- Maximum of one (1) participant in the Zorb Inflatable at any time.
- Maximum participant weight: 100 kg (220 lbs).

Weather & Wind Restrictions

- Outdoor use is not permitted during:
 - Rain
 - Wind speeds exceeding Beaufort Force 5 (28–38 km/h) – ie: small trees swaying
